2015 WATER SUPPLY IMPROVEMENTS**

ADVERTISEMENT FOR BIDS

Sealed Bids for the construction of the **2015 Water Supply Improvements**, will be received, by **Doniphan County RWD No. 6**, at the **Highland Community Center, 501 West Ave., Highland, KS 66035**, until **2:00 pm** local time on **December 15, 2015**, at which time the Bids received will be **publicly** opened and read. The Project consists of constructing **approximately 605,000 LF of 2", 2½", 3", 4", 6", 8" and 10" PVC water line, one 12' diameter x 130' tall welded steel standpipe, directional bored stream, river, county road and highway crossings, flush hydrants, gate valves, water services and miscellaneous appurtenances.**

The waterline Bid Items listed herein are predicated on ASTM D2241 Iron Pipe Size (IPS) PVC pipe. Alternative pipe materials will be evaluated for equivalency upon request in accordance with the Contract Documents.

A pre-bid meeting will be held on Monday, November 30th, 2015 at 10:00 a.m. at the Highland Community Center, 501 West Ave., Highland, Kansas. Due to the importance of all bidders having a clear understanding of the specifications and scope of work requirements of this project, attendance at the pre-bid meeting is strongly encouraged.

Bids will be received for a single prime Contract. Bids shall be on based on lump sum and unit prices, with additive alternate bid items as indicated in the Bid Form.

Bidding Documents also may be examined at **Highland City Hall, 220 W. Main Street, Highland, KS 66035**, on Monday through Friday between the hours of **8:00 am – 12:00 pm** and **1:00 pm – 4:00 pm**.

Printed copies of the Bidding Documents may be obtained from the Issuing Office, during the hours indicated above, upon payment of **\$300.00** (non-refundable) for each set. Checks for Bidding Documents shall be payable to "**Schwab Eaton.**" Upon request and receipt of the document payment indicated above, the Issuing Office will transmit the Bidding Documents via delivery service. Bidding Documents may also be accessed online at www.schwab-eaton.com with a paid yearly subscription fee.

The Owner reserves the right to waive any informalities or to reject all bids.

Each Bidder must deposit with his bid, security in the amount, form and subject to the conditions provided in the information for Bidders.

This project is funded by USDA Rural Development. Associated certifications and the completion of other documents will be required for the successful completion of the project. All bidders are required to comply with Local, State and Federal regulations as stated in the bid documents.
