Request for CMAR Qualifications to USD 200 - Greeley County Schools in Tribune, KS

Greeley County Schools in Tribune, KS is soliciting qualifications from General Contractors/Construction Managers to provide Construction Manager, At Risk (CMAR) services as per K.S.A. 72-1155 for improvements to the gym entrance and lobby as well as the kitchen at the school.

The scope of the facility improvements will include the following:

## Main Gym

- 1. Replace the west entrance of 58' X 9' 5" to the main gym along with 8 new outside doors.
- 2. Replace 3 sets of 2 other outside entrance doors to the main gym
- 3. Replace the west entrance outside concrete & sidewalk up to the sidewalk parallel with the parking lot and provide proper drainage from that area as part of the new concrete work
- 4. Replace the main gym lobby ceiling tiles and the plumbing that runs through that area
- 5. Replace the ceiling lighting in the main gym lobby
- 6. Replace the gym lobby floor tile
- 7. Completely remodel the main gym lobby restrooms for both men and women

## <u>Kitchen</u>

- 1. Install FRP wall covering that may be glued/adhered to the existing wall covering
- 2. Remove all non stainless steel countertops and install new stainless steel countertops
- 3. Remove the existing floor tile, prepare the subsurface, and install an epoxy flooring material such as the Dur-A-Quartz grade from Dur-A-Flex
- 4. Remove and install new ceiling tile grid and washable ceiling tiles

USD 200 is soliciting proposals in a three-stage qualifications based selection process:

Phase I. Written qualifications from potential CMAR's must be submitted no later than 1:00 p.m. MT Friday, February 7th, 2020 with prequalifying a minimum of 3 but no more than 5 firms.

Phase II. Proposals for the projected construction from prequalified potential CMAR's.

Phase III. Interviews of prequalified potential CMAR's with the USD 200 Board of Education in executive session.

#### Phase I. Submittal Content

- 1. Similar project experience
- 2. Experience in this type of project delivery system
- 3. References from design professionals and owners from previous projects
- 4. Description of the Construction Manager or General Contractor's project management approach
- 5. Bonding capacity firms shall be capable of providing a public works bond in accordance with K. S. A. 60-1111.
