The Project is generally described as a mill and overlay of K-4 Highway from West City Limits (South Coronado Avenue) to South Main Street which consists of the following major items: 9,664 Sq. Yds. Milling, 1,576 Tons Hot Mix Asphalt (HMA) Commercial Grade, 358 Tons of HMA Commercial Grade Pavement Patching, Sealing Asphalt Cracks, Pavement Marking, and Traffic Control.
