The Project includes the following Work:

Water Distribution System Improvements: Work includes furnishing all the labor, materials, and equipment for constructing approximately 5,472 linear feet of 6-inch waterline; 761 linear feet of 4-inch waterline; 459 linear feet of 2-inch waterline; associated directional drill installation where necessary; valves; hydrants; water service connections; water service meters; water service meter pits; connections to system; existing pipeline abandonment; grass seeding; gravel surfacing; erosion control and all other incidental and appurtenant work required to complete the improvements as shown and specified.

Alternates: Additional waterline and water service connections in various areas.

This project is funded by a Kansas Department Health and Environment Revolving Loan (KPWSLF). Bidder's attention is called to the required compliance with KPWSLF funding requirements.

Bidders on this work, including subcontractors or vendors, will be required to comply with the Kansas Act Against Discrimination (K.S.A. 44-1001 et.seq.) and the Kansas Age Discrimination in Employment Act (K.S.A. 44-1111 et.seq.). Requirements for bidders are explained in the Bid Documents.

Bidders must fully comply with Subpart C of 2 CFR Part 180 and 2 CFR 1532, entitled Responsibilities of Participants Regarding Transactions. Contractors, subcontractors, or suppliers that appear on the Excluded Parties List System at www.sam.gov are not eligible for award of any contracts funded by the KDHE State Revolving Fund programs.

All contracts and subcontracts exceeding \$100,000, at any tier under a SRF Loan Agreement shall comply with the Anti-Lobbying Act, Section 319 of Public Law 101-121, and file an Anti-Lobbying Certification form, and the Disclosure of Lobbying Activities form, if required, to the next tier above.
