Water System Improvements: Work includes furnishing all the labor, materials, and equipment for constructing approximately 4,792 linear feet of 4-inch waterline; 907 linear feet of 2-inch waterline; associated directional drill installation where necessary; valves; hydrants; water service connections; water service meters; water service meter pits; connections to system; existing pipeline abandonment; grass seeding; gravel surfacing; erosion control and all other incidental and appurtenant work required to complete the improvements as shown and specified.
