The City of Galva (Owner) is requesting Bids for the construction of the following Project:

City of Galva, KS - Water Storage Tank – Phase 1 - Bid Package 2

Bids for the construction of the Project will be received at the office of the City Clerk located at 208 S. Main St, Galva, KS 67443, until October 2nd, 2025, at 2:00 PM local time. At that time, the Bids received will be publicly opened and read.

The Project includes the following Work:

Water Storage Tank: Work includes furnishing all the labor, materials, and equipment for construction of a 31-foot diameter, 200,000 gallon ground storage tank, complete with tank, concrete foundation, piping; site piping, hydrants, valves and appurtenances; earthwork; and all other incidental and appurtenant work required to complete the improvements as shown and specified.

The owner anticipates that the Project's total bid price will be approximately \$500,000. The Project has an expected duration of 120 calendar days.

Contractors, subcontractors, or suppliers that appear on the Excluded Parties List System at www.sam.gov are not eligible for award of any contracts funded by the KDHE State Revolving Fund programs.
