Bids for the construction of the Project will be received at the office of the City Clerk located at 415 W. 2nd Street, Oakley, KS, 67748, until March 3rd, 2026, at 1:30 PM local time. At that time, the Bids received will be publicly opened and read.

The Project includes the following Work:

Water Treatment Plant: Work includes furnishing all the labor, materials, and equipment for construction of a new water treatment plant. Work in general includes: piping, fire hydrants, meters, valves, and appurtenances, site earthwork and compaction, waste holding pond and appurtenances, electrical, treatment equipment purchase and installation, water treatment equipment, pumps, chemical feed equipment, pre-engineered steel building, concrete, masonry, and architectural work, mechanical work and equipment, miscellaneous metal equipment, potable water tank and equipment, nitrate waste tank and equipment, gravel drive and entrance work, telemetry system, and all other incidental and appurtenant work required to complete the improvements as shown and specified.

Owner anticipates that the Project's total bid price will be approximately \$4,000,000. The Project has an expected duration of 365 days.
